The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 861, as amended, and as specificially amended by By-laws 29-81 and 175-79, is hereby further amended:
 - (1) by deleting sections 292.1.4 (12) and 292.1.4 (13).
 - (2) by deleting the part of Schedule A to By-law 861 added thereto by By-law 29-81, and substituting therefor Schedule A attached to this by-law.
 - (3) by deleting section 230.1.2 and renumbering section 230.1.3 to section 230.1.2.
 - (4) by deleting section 232.1.2 and renumbering section 232.1.3 to section 232.1.2.
 - (5) by deleting section 233.1.2 and renumbering section 233.1.3 to section 232.1.2.
 - (6) by deleting section 235.1.2 and renumbering section 235.1.3 to 235.1.2.
 - (7) by deleting the parts of Schedule A to By-law 861 added thereto by By-law 175-79, and substituting therefor Schedule B attached to this by-law.



Zone Boundary



KEY PLAN







Part Lots 9,10 Con. 3 E.H.S.




