A By-law to authorize the execution of an Amending Agreement between The Corporation of the City of Brampton and The Brampton Tennis Club

The Council of The Corporation of the City of Brampton ENACTS as follows:

That the Mayor and the Clerk are hereby authorized to execute an Amending Agreement between The Corporation of the City of Brampton and The Brampton Tennis Club, attached hereto as Schedule "A".

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 26th day of April, 1976.

BETWEEN:

THE CORPORATION OF THE CITY OF BRAMPTON

hereinafter called the 'City'

OF THE FIRST PART

A N D

THE BRAMPTON TENNIS CLUB

hereinafter called the 'Club'

OF THE SECOND PART

WHEREAS the parties hereto entered into an agreement dated the 22nd day of September 1975 relating to the construction of two new tennis courts and fencing and the construction of a new tennis clubhouse and the lease of the existing and proposed facilities by the City to the Club provided that the Club pay fifty per cent (50%) of the capital cost of the improvements;

AND WHEREAS the capital cost of the improvements was estimated at that time to be Eighty Thousand Dollars (\$80,000.00) and the Club's share was limited in the agreement to Forty Thousand Dollars (\$40,000.00);

AND WHEREAS the present indications are that the cost of the improvements will be approximately Eighty-Six Thousand Dollars (\$86,000.00);

AND WHEREAS the parties hereto wish to provide that the excess cost over the original Eighty Thousand Dollars (\$80,000.00) anticipated cost will be borne by them equally in accordance with the terms of this agreement;

NOW THEREFORE THE PARTIES HERETO AGREE as follows:

(1) The agreement dated the 22nd day of September 1975 between the City and the Club is hereby amended by the addition of a term that, in addition of all payments provided for in the agreement of 22nd of September 1975, the Club shall also pay to the City fifty per cent (50%) of the cost of all capital improvements in excess of the originally estimated total cost of Eighty Thousand (\$80,000.00) plus interest at ten per cent (10%) on the portion of the excess to be paid by the Club, in twenty consecutive annual payments to be paid not later than the 1st day of June in each year of the lease.

IN WITNESS WHEREOF THE PARTIES HAVE hereunto set their hands and seals by the hands of their officers duly authorized in that behalf.
