WHEREAS paragraph 45 of section 207 of the Municipal Act (R.S.O. 1990, c. M.45, as amended) provides that a municipality may pass by-laws for appointing such officers and servants as may be necessary for carrying into effect the provisions of any by-law of the Council, and for prescribing their duties;

AND WHEREAS section 15 of the of the Police Services Act (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality.

AND WHEREAS it is necessary to appoint additional officers to enforce the provisions of By-law 93-93, as amended (which regulates parking on private property) in respect of certain private properties;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The individuals named in Column 1 of Schedule A to this By-law are hereby appointed as By-law Enforcement Officers for the purpose of By-law 93-93, as amended, but only in respect of the corresponding properties named and identified in Column 2 of Schedule A to this By-law. Where no municipal address is set out in Column 2 the said officers may enforce By-law 93-93, as amended in respect of all the properties located upon the streets listed in Column 2.
2. In enforcing By-law 93-93, as amended, a By-law Enforcement Officer appointed under this by-law may only take the actions authorized by Section 46(1) of by-law 93-93, as amended.
3. By-law 214-92 is hereby repealed.
