

## **BY-LAW**

To change the names of Sandhill Court and Carson Court (Part of Block J, Plan 977)

WHEREAS the Council of the City of Brampton enacted By-law 216-86 to establish certain lands as Sandhill Court and Carson Court.

AND WHEREAS the legal descriptions for the lands comprising the two streets were inadvertently reversed in Schedule A to By-law 216-86.

AND WHEREAS the Council of the City of Brampton deems it expedient to correct the said error by changing the names of Sandhill Court and Carson Court;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Times, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. The name of "Carson Court", comprised of the lands described firstly in Schedule A to this by-law, is changed to "Sandhill Court".
- 2. The name of "Sandhill Court", comprised of the lands described secondly in Schedule A to this by-law is changed to "Carson Court".
- 3. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.
