**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to STOP SIGNS (Schedule IV),
THROUGH HIGHWAYS (Schedule III) and NO PARKING (Schedule XIV)**

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule IV:

STOP SIGNS

| COLUMN 1 INTERSECTION or LOCATION | COLUMN 2 FACING TRAFFIC |
|---|----------------------------------|
| Charolais Boulevard and James Potter Road | Eastbound on Charolais Boulevard |
| Charolais Boulevard and James Potter Road | Northbound on James Potter Road |
| Charolais Boulevard and James Potter Road | Southbound on James Potter Road |

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

| Elbern Markell Drive and Crocus Street/Ingleborough Drive | Northbound on Elbern Markell Drive |
| Elbern Markell Drive and Crocus Street/Ingleborough Drive | Eastbound on Crocus Street |
| Creditview Road and George Robinson Drive | Southbound on Creditview Road |
| Creditview Road and George Robinson Drive | Westbound on George Robinson Drive |
| Creditview Road and George Robinson Drive | Northbound on Creditview Road |
| Bonnie Braes Drive and Creditview Road | Southbound on Creditview Road |

3. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN |
|---------------------|---|
| Creditview Road | The south limit of Queen Street West and the north limit of Steeles Avenue West |
| Charolais Boulevard | The east limit of Moffatt Avenue/Torrance Woods (westerly intersection) and the west limit of Moffatt Avenue/Torrance Woods (easterly intersection) |
| Charolais Boulevard | The east limit of Moffatt Avenue/Torrance Woods (easterly intersection) and the west limit of Main Street South |

4. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN |
|---------------------|--|
| Creditview Road | The south limit of Queen Street West and the north limit of George Robinson Drive |
| Creditview Road | The south limit of George Robinson Drive and the north limit of Bonnie Braes Drive |
| Creditview Road | The south limit of Bonnie Braes Drive and the north limit of Steeles Avenue West |
| Charolais Boulevard | The east limit of James Potter Road and the west limit of Main Street South |

5. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule XIV:

NO PARKING

| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|---------------------|------------------|---------------------------------|--|
| Main Street South | East | John Street and Woodbrook Drive | Anytime except 7:00 am to 2:00 pm Sunday |

6. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XIV:


NO PARKING


| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|---------------------|------------------|--|--|
| Main Street South | East | John Street and a point 40 metres south of Wellington Street | Anytime except 7:00 am to 2:00 pm Sunday |
| Main Street South | East | A point 40 metres south of Wellington Street and Woodbrook Drive | Anytime |
