

BY-LAW

Number	108-86	
To amend (Rowntre	By-law 160-8 e Drain)	34

WHEREAS the council of The Corporation of the City of
Brampton passed By-law 160-84 on 13 August 1984, authorizing the
construction of certain drainage works on Lots 11, 12 and 13,
Concession 4, West of Hurontario Street, in the geographic
Township of Chinguacousy, to be known as the Rowntree Drain;

AND WHEREAS the council of The Corporation of the City of Brampton amended By-law 160-84 by passing By-law 203-85 on 9 September 1985, to extend the Rowntree Drain;

AND WHEREAS the Rowntree Drain project was constructed in accordance with the provisions of the <u>Drainage Act</u> (R.S.O. 1980, c. 126, as amended);

AND WHEREAS By-law 160-84, as amended, provided for a total estimated cost of \$61,200.00 for the construction of the Rowntree Drain;

AND WHEREAS the actual cost to construct the Rowntree Drain was \$58,228.09;

AND WHEREAS CN Rail and Transcanada Pipelines are chargeable a special assessment of \$3,499.15;

AND WHEREAS the remainder of the construction cost, being \$54,728.94, is assessable, on a <u>pro rata</u> basis, against the lands and roads set out in Schedules A and B to By-law 160-84, using a prorating factor of 111.2%;

NOW THEREFORE the council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 160-84, as amended by By-law 203-85, is hereby further amended, by deleting therefrom Schedules A and B thereto, and substituting therefor Schedules A and B to this by-law.

READ A FIRST, SECOND AND THIRD TIME AND PASSED IN OPEN COUNCIL THIS $^{26\text{th}}$ DAY OF $^{\text{May}}$, 1986.


