A By-law to Amend By-law 102-94 Which Appoints Officers to Enforce Parking on Private Property and to repeal By-law 92-2001


THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON ENACTS AS FOLLOWS:


