
To accept and assume as public
highways certain lands shown
on Registered Plan M-232


WHEREAS it is deemed expedient to accept and assume certain streets and lands, and to establish other lands, shown on Registered Plan M-232 as public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The lands dedicated as public highways and described in Schedule A to this by-law be and the same are hereby accepted and assumed as part of the public highway system of the City of Brampton.
2. The lands acquired by The Corporation of the City of Brampton, and described in Schedule B to this by-law, be and the same are hereby established as part of the public highway system of the City of Brampton.

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL this 11th day of April, 1983.
