# BY-LAW

Number 112-89

To amend By-law 151-88, as amended, (part of Lot 11, Concession 4, W.H.S., former Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

(1) by changing on Sheet 21B of Schedule A thereto, the zoning designation of the land outlined on Schedule A to this by-law from AGRICULTURAL (A) to INSTITUTIONAL ONE SECTION 470 (I1-SECTION 470), the lands being part of Lot 11, Concession 4, West of Hurontario Street, in the geographic Township of Chinguacousy.

(2) by adding thereto the following section:

"470 The lands designated I1-SECTION 470 on Sheet Number 21-B of Schedule A to this by-law:

470.1 shall only be used for the purposes permitted in the I1 zone;

470.2 shall be subject to the following requirements and restrictions:

(a) parking:

- 1 parking space for every 4 fixed seats or 2 metres of open bench space or portion thereof.

470.3

shall also be subject to the requirements and restrictions relating to the I1 zone and all general provisions of this by-law which are not in conflict with the ones set out in section 470.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,
