**BY-LAW** 

Number \_\_\_\_\_ 113-90

To amend By-law 151-88 (part of Lot 5, Concession 5, E.H.S. in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

- (1) by deleting therefrom, section 380 and substituting therefor the following:
  - "380.1 the lands designated SC-SECTION 380 on Sheet 64-B of Schedule 'A' to this by-law.
  - 380.1.1 shall only be used for the following purposes:
    - (1) an office
    - (2) medical centre
    - (3) a bank, trust company or financial institution
    - (4) pharmacy
    - (5) only one coffee shop
    - (6) purposes accessory to the other permitted purposes.

380.1.2 shall be subject to the following requirements and restrictions:

 coffee shop shall not exceed a gross commercial floor area of 105 square metres.

- (2) no advertisement, that can be seen from outside of the building, shall be permitted to give notice that a coffee shop is located within the building.
- 380.1.3 shall also be subject to the requirements and restrictions relating to the SC zone and all the general provisions of this bylaw which are not in conflict with the ones set out in section 380.1.2.
- 380.2 for the purposes of this section, <u>Pharmacy</u> shall mean a retail establishment dispensing prescription drugs, pharmaceuticals, patent medicines, personal health, medical and therapeutical appliances and equipment or any item which is prescribed or recommended by a physician."
