To prevent the application of part lot control to part of Registered Plan 43M-1402 and 43M-1403

WHEREAS subsection 50(5) of the Planning Act, R.S.O. 1990 c.P.13, has imposed part lot control on all lands within registered plans within the City;

AND WHEREAS, pursuant to subsection 50(7) of the Planning Act, the Council of a municipality may by by-law provide that part lot control does not apply to lands within such registered plans or parts thereof as are designated in the by-law;

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

1.

Subsection 5 of section 50 of the <u>Planning Act</u>, does not apply to the following lands:

City of Brampton, Regional Municipality of Peel, being composed of:

- the whole of Lots 39 to 42 inclusive, 44 to 45 inclusive, 48, 49, 69, 70, 72, 73, 75, 76, 77, 81, 83 to 88 inclusive, 90, 91 and 93, on Registered Plan 43M-1402
- the whole of Lots 2, 3, 5 to 7 inclusive, 9 to 12 inclusive, 14, and 30 to 39 inclusive, on Registered Plan 43M-1403
