## **BY-LAW**

To change the name of Prairie Dog Circle (Plan 43M-1115)

WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to change the name of Prairie Dog Circle;

AND WHEREAS notice of the intention to pass this bylaw has been published one a week for four successive weeks in The Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. The name of the street shown as "Prairie Dog Circle" on Registered Plan 43M-1115 is changed to "Prairie Rose Circle".
- 2. The affidavit of Leonard J. Mikulich attached as Schedule A hereto shall form part of this by-law.
