BY-LAW

Number 117-80

To adopt the proceedings of Council Meeting of the 21st day of April, 1980 and to authorize their execution.

WHEREAS by Section 241 (1) of The Municipal Act, Chapter 284, R.S.O. 1970, as amended, the powers of Council are to be exercised by By-law;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. THAT the proceedings of the meeting of the Council of the Corporation of the City of Brampton held on the 21st day of April, 1980 and including all Resolutions, By-laws, Recommendations, Adoption of Committee Reports and all other motions and matters duly approved in the said Council Meeting are hereby adopted and confirmed as if all such proceedings were expressly embodied in this By-law.
- 2. THAT the Mayor and the Clerk are hereby authorized to direct other officials of the City and to take all necessary action to carry out the proceedings of Council as referred to in Paragraph One herein.
