To amend Interim Control By-Law 35-2013, An Interim Control By-Law applicable to Part of the Area Subject to By-Law 270-2004, as amended, and known municipally as 50 Salem Court.

The Council of the Corporation of the City of Brampton ENACTS as follows:

By-Law 35-2013, as amended, is hereby amended as follows:

1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2 and Section 1.3", the following:

"Section 1.4"

1.2 The following is added as Section 1.4:

"1.4 On lands described as Concession 1 EHS, Part of Lot 10, as the "Lands Subject to Specific Exemption From Interim Control By-Law 35-2013, as amended by By-Law <u>112-2013</u>" and as shown on Schedule A to this by-law as 50 Salem Court, there shall be permitted an addition to the principal building resulting in a total gross floor area of the principal building not exceeding 204 square metres."

By-Law 35-2013 is hereby further amended by adding thereto, as Schedule C, Schedule A to this by-law.

READ a FIRST, SECOND AND THIRD TIME, and PASSED, in OPEN COUNCIL, this 8<sup>TH</sup> day of May 2013.



#### DECLARATION
