# BY-LAW

Number 120-76

A By-law to amend By-law Number 37-74, respecting parking meters on the streets within the Corporation of the City of Brampton.

WHEREAS the Council of The Corporation of the City of Brampton deems it expedient and advisable to further amend By-law Number 37-74, being a by-law respecting parking meters on streets within The Corporation of the City of Brampton.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- (1) That Schedule "A" to By-law Number 37-74 as amended be further amended by the deletion therefrom of the following, under the appropriate columns thereof.

Column 1 <u>Road</u>	Column 2 <u>Side</u>	Column 3 <u>Between</u>	Column 4 <u>Fees &amp; Time Limits</u>	Column 5 <u>Maximum Parking Period</u>
Queen St. W.	South	A point 136 feet west of the centre line of Main Street S. and a point 58 feet east of the centre line of George Street S.	5¢ for 15 min. 10¢ for 30 min.	60 min.
Queen St. W.	North	A point 143 feet west of the centre line of Main Street N. and a point 122 feet east of the centre line of George Street N.	5¢ for 15 min. 10¢ for 30 min.	60 min.
Main St. N.	East	A point 142 feet north of the centre line of Queen Street E. and a point 52 feet south of the centre line of California Street	5¢ for 15 min. 10¢ for 30 min.	60 min.




Column 1 <u>Road</u>	Column 2 <u>Side</u>	Column 3 <u>Between</u>	Column 4 <u>Fees &amp; Time Limits</u>	Column 5 <u>Maximum Parking Period</u>
Queen St. W.	South	A point 114 feet west and a point 134 feet west of the centre line of Main Street	5¢ for 15 min. to 20¢ for 60 min.	60 min.
Queen St. E.	North	A point 77 feet east of the centre line of Hanna Street and a point 398 feet west of the centre line of Union Street	5¢ for 15 min. 10¢ for 30 min.	60 min.
Queen St. E.	South	A point 193 feet east of the centre line of Main Street S. and a point 50 feet west of the centre line of Chapel Street	5¢ for 15 min. 10¢ for 30 min.	60 min.

(2) That Schedule "A" to By-law Number 37-74 as amended be further amended by the addition thereto of the following under the appropriate columns thereof.

Main Street North	East	A point 185 feet north of Queen Street E. and a point 52 feet south of the centre line of California St.	5¢ for 15 min. 10¢ for 30 min.	60 min.
Queen St. E.	North	A point 163 feet east of Main Street N. and a point 398 feet west of the centre line of Union Street	5¢ for 15 min. 10¢ for 30 min.	60 min.
Queen St. E.	South	A point 127 feet east of Main Street S. and a point 50 feet west of the centre line of Chapel Street	5¢ for 15 min. 10¢ for 30 min.	60 min.
