Agricultural (A)	Residential Single Detached F – 21.0 (R1F-21.0), Residential Single Detached F – 13.5 (R1F-13.5), Residential Single Detached F - 11.6 (R1F-11.6), Residential Single Detached F – 10.4 (R1F-10.4), Residential Semi Detached E – 7.5 (R2E-7.5), Institutional One – Section 1981 (I1-1981), Open Space – Section 1970 (OS-1970), Open Space (OS), and Floodplain (F).

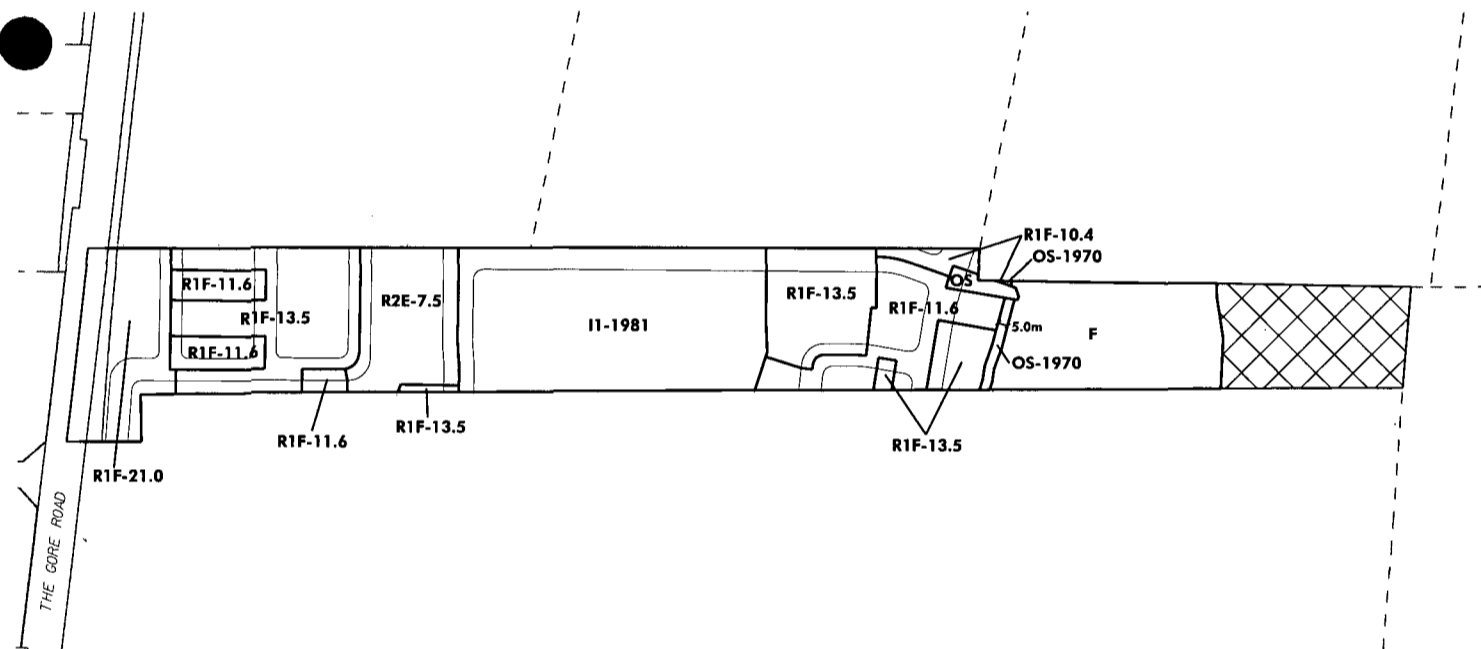

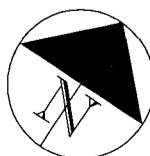

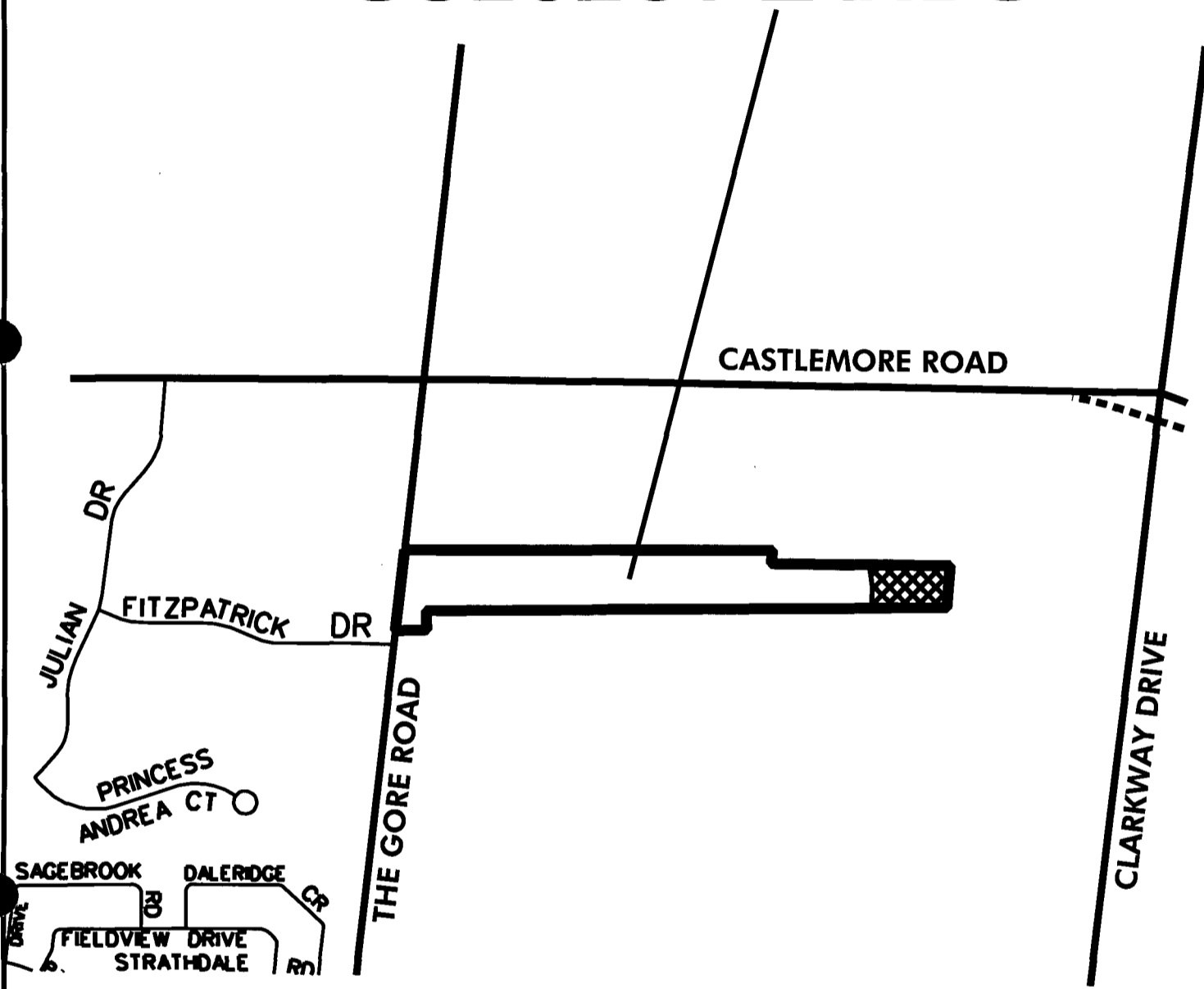

as follows:


1. I am the Deputy Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared:
