



DECLARATION

 - 1. I am the Deputy Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared:
 - 2. By-law 122-2009 was passed by the Council of the Corporation of the City of Brampton at its meeting on 22nd day of April, 2009.
