A BY-LAW TO AMEND BY-LAW #149-75 RESPECTING PARKING METERS ON THE PARKING LOT ON GEORGE STREET N. WITHIN THE CORPORATION OF THE CITY OF BRAMPTON.

WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 149-75, BEING A BY-LAW RESPECTING PARKING METERS ON THE PARKING LOT ON GEORGE STREET NORTH WITH THE CORPORATION OF THE CITY OF BRAMPTON.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON ENACTS AS FOLLOWS:

- 1. That By-Law Number 149-75 be amended by the deletion therefrom of the following sections seven (7) and eight (8).
  - 7. The provisions of this by-law respecting payment of a fee for parking and maximum parking period shall apply only during the hours of 9:00 a.m. to 6:00 p.m. on Monday, Tuesday, Wednesday and Saturday and from 9:00 a.m. to 9:00 p.m. on Thursday and Friday, except Statutory Holidays falling on such days and the first Monday in August and such other day or days as may be lawfully proclaimed a holiday.
  - 8. THE FEES TO BE DEPOSITED IN A METER FOR THEHUSE OF CA PARKING, SPACE SHALL BE AS FOLLOWS:

30 MINUTES FOR EACH FIVE CENT PIECE, AND ONE HOUR FOR EACH TEN CENT PIECE TO THE MAXIMUM TIME ON THE DIAL OF TWO HOURS. FOR CONVENIENCE, TWO HOURS FOR A TWENTY-FIVE CENT PIECE. THE MAXIMUM PARKING PERIOD FOR A VEHICLE SHALL BE TWO HOURS.

- 2. THAT BY-LAW NUMBER 149-75 BE 'AMENDED BY THE ADDITION THERETO OF THE FOLLOWING:
  - 7. THE PROVISIONS OF THIS BY-LAW RESPECTING PAYMENT OF A FEE FOR PARKING AND MAXIMUM PARKING PERIOD SHALL APPLY ONLY DURING THE HOURS OF 9:00 A.M. TO 6:00 P.M. ON MONDAY TO SATURDAY INCLUSIVE, EXCEPT ON STATUTORY HOLIDAYS OR OTHER SUCH DAYS AS MAY BE LAWFULLY PROCLAIMED A HOLIDAY.
  - 8. THE FEE TO BE DEPOSITED IN A METER FOR THE USE OF A PARKING SPACE SHALL BE:
    - (A) 20¢ FOR 60 MINUTES
    - (B) FOR A MAXIMUM PARKING PERIOD OF 120 MINUTES
