To amend amended, Concession	(Part	of Lot	as 8,

The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 200-82, as amended is hereby further amended by:
 - (1) by changing, on Sheet 8 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from COMMERCIAL ONE SECTION 139 (C1 SECTION 139) and HIGHWAY COMMERCIAL ONE SECTION 112 (HC-SECTION 112) to COMMERCIAL ONE SECTION 139 (C1 SECTION 139), such lands being part of Lot 8, Concession 1, East of Hurontario Street, in the geographic Township of Chinguacousy;
 - (2) by deleting therefrom SCHEDULE C 139 and substituting therefor, as SCHEDULE C 139, Schedule B to this by-law;
 - (3) by deleting therefrom Section 139 and substituting therefor the following:
 - "139 The lands designated Cl Section 139 on Sheet 8 of Schedule A to this by-law:
 - 139.1 shall only be used for the following purposes:
 - (1) a dry cleaning and laundry establishment, using non-toxic, non-flammable materials only.
 - (2) the purposes permitted in a Cl zone by section 21.1.1 with the exception of:
 - (a) a religious institution including an associated place of public assembly, and
 - (b) a dining room restaurant, a fast food restaurant, and a standard restaurant.

- 139.2 shall be subject to the following requirements and restrictions:
 - (1) all buildings shall be located within the areas shown as BUILDING AREA on SCHEDULE C - SECTION 139;
 - (2) landscaped open space shall be provided and maintained in the areas shown as LANDSCAPED OPEN SPACE on SCHEDULE C - SECTION 139;
 - (3) the gross commercial floor area of all buildings, shall not exceed 1057 square metres;
 - (4) the maximum height of all structures shall not exceed 1 storey;
 - (5) parking shall be provided in accordance with section 20.3 of this by-law;
 - (6) all garbage and refuse containers shall be enclosed, with the exception of a roof;
 - (7) garbage and refuse containers for a restaurant shall be located within a climate-controlled area within the building;
 - (8) an adult entertainment parlour shall not be permitted, and
 - (9) no outside storage or display of goods shall be permitted.
- 139.3 shall also be subject to the requirements and restrictions relating to the C1 zone and all the general provisions of this by-law which are not in conflict with the ones set out in section 139.2.




