To amend By-law 56-83; By-law 139-84; and By-law 151-88, as amended.

The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-Law 56-83, as amended, is hereby further amended:
 - 1) By adding to the Table of Contents the following new words: "Schedule "E" Lester B. Pearson International Airport" after the reference to Schedule D.
 - 2) By revising the first paragraph of Section 3.2 (1) Schedules, with the following new words: "Schedules A, C, D and E with notations and references shown thereon, are hereby declared to be part of this by-law and are described as follows."
 - 3) By adding to Section 3.2 (1) Schedules, the following new words: "Schedule E: Lester B. Pearson International Airport Operating Area" after the reference to Schedule D.
 - 4) By adding to Section 6.0 GENERAL PROVISIONS FOR ALL ZONES, a new subsection 6.34 <u>Lester B. Pearson İnternational</u> Airport Operating Area as follows:
 - 6.34 <u>Lester B. Pearson International Airport Operating</u>
 Area:

Notwithstanding any provision in this By-Law to the contrary, the uses permitted by this By-Law in any zone situated within the area identified as the "Lester B. Pearson International Airport Operating Area" on Schedule E of this section shall not include a

residential dwelling, a day nursery, a hospital, a nursing home, a public school and a private school, either as accessory or principle uses, provided that:

- (a) a residential dwelling, a day nursery, a hospital, a nursing home, a public school and a private school which legally exists on the day this section comes into effect and in conformity with this By-Law, and such uses shall continue to be subject to the provisions of this By-Law as they exist on the day this section comes into effect.

- 5) By adding Schedule "C" to this By-Law as Schedule "E" to By-Law 151-88.
- 4. This By-Law shall not come into effect until Official Plan Amendment OP93-<u>215</u> comes into force.







DECLARATION

I, LEONARD JOSEPH MIKULICH, of the City of Brampton, in the Regional Municipality of Peel, DO SOLEMNLY DECLARE THAT:

- 1. I am the Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
- By-law 125-2003 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 12th day of May, 2003, to adopt Amendment Number OP93-215 to the 1993 Official Plan of the City of Brampton Planning Area.
- 3. By-law 126-2003 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 12th day of May, 2003, to amend Comprehensive Zoning By-laws 56-83, 139-84 and 151-88, as amended.
- 4. Written notice of By-law 125-2003 as required by section 17(23) and By-law 126-2003 as required by section 34(18) of the *Planning Act* was given on the 23rd day of May, 2003, in the manner and in the form and to the persons and agencies prescribed by the Planning Act, R.S.O. 1990 as amended.
- 5. No notice of appeal was filed under sections 17(24) and 34(19) of the *Planning Act* on or before the final date for filing objections.
- 6. In all other respects this Official Plan Amendment has been processed in accordance with all of the Planning Act requirements including regulations for notice.
- 7. OP93-215 is deemed to have come into effect on the 12th day of May, 2003, in accordance with Section 17(27) of the *Planning Act*, R.S.O. 1990, as amended.
