To amend By-law 93-93,
**FIRE ROUTES, NO PARKING
and STOP SIGNS**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule XXII thereto the following items:

(2) by deleting from Schedule XIV thereto the following items:

NO PARKING


