A by-law to stop up and close and authorize the sale of part of Bark Street

WHEREAS the Corporation of the City of Brampton has assumed Park Street as a public highway; AND WHEREAS it is deemed expedient by the Corporation of the City of Brampton that a certain part of Park Street be closed and stopped up, and sold to the owners of the abutting lands;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four consecutive weeks in the Daily Times, a newspaper published in the City of Brampton;

AND WHEREAS the said corporation has given notice to the Regional Municipality of Peel, pursuant to section 51 of <u>The Regional Municipality of Peel Act, 1973</u>, and the Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the said Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard; NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS AS FOLLOWS:

 The part of Park Street more particularly described in Schedule A attached to this by-law be and the same is hereby stopped up and closed. 2. The sale of the land stopped up and closed by this by-law to the owner of the abutting land for the sum of \$2.00 is hereby authorized.

3. The Mayor and the Clerk are hereby authorized to execute all documents and instruments necessary to complete the sale of the land stopped up and closed by this by-law.

SCHEDULE A TO BY-LAW 128-79

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Town of Brampton, in the County of Peel) being part of the East half of Lot 6, Concession 1, West of Hurontario Street and being composed of part of Lot 66, in Block 4 according to a plan in the Land Registry Office for the Registry Division of Peel (No. 43) referred to as BR-4, and designated as Parts 2 and 3 on a reference plan deposited in the said Land Registry Office as number 43R-6502.
