BY-LAW

Number 131-90

To amend By-law 151-88, as amended
(part of Lot 10, Concession 2, E.H.S.
in the geographic Township of
Chinguacousy)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

(1) by changing, on Sheet 44A of Schedule A thereto,
the zoning designation of the lands shown outlined
on Schedule A to this by-law from AGRICULTURAL (A)
to INSTITUTIONAL TWO-SECTION 558 (I2-SECTION 558)
being part of Lot 10, Concession 2, East of
Hurontario Street, in the geographic Township of
Chinguacousy.

(2) by adding thereto the following section:


"558 The lands designated I2 - SECTION 558 on
Sheet 44A of Schedule A to this by-law:

558.1 shall only be used for:

- (1) an art gallery operated by a public authority
- (2) a library
- (3) a park, playground or recreation facility operated by a public authority
- (4) a restored historic dwelling used for cultural, educational or instructional purposes
- (5) purposes accessory to the other permitted purposes.

558.2 shall also be subject to the requirements and restrictions relating to the I2 zone and all the general provisions of this by-law."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 16th day of July 1990.

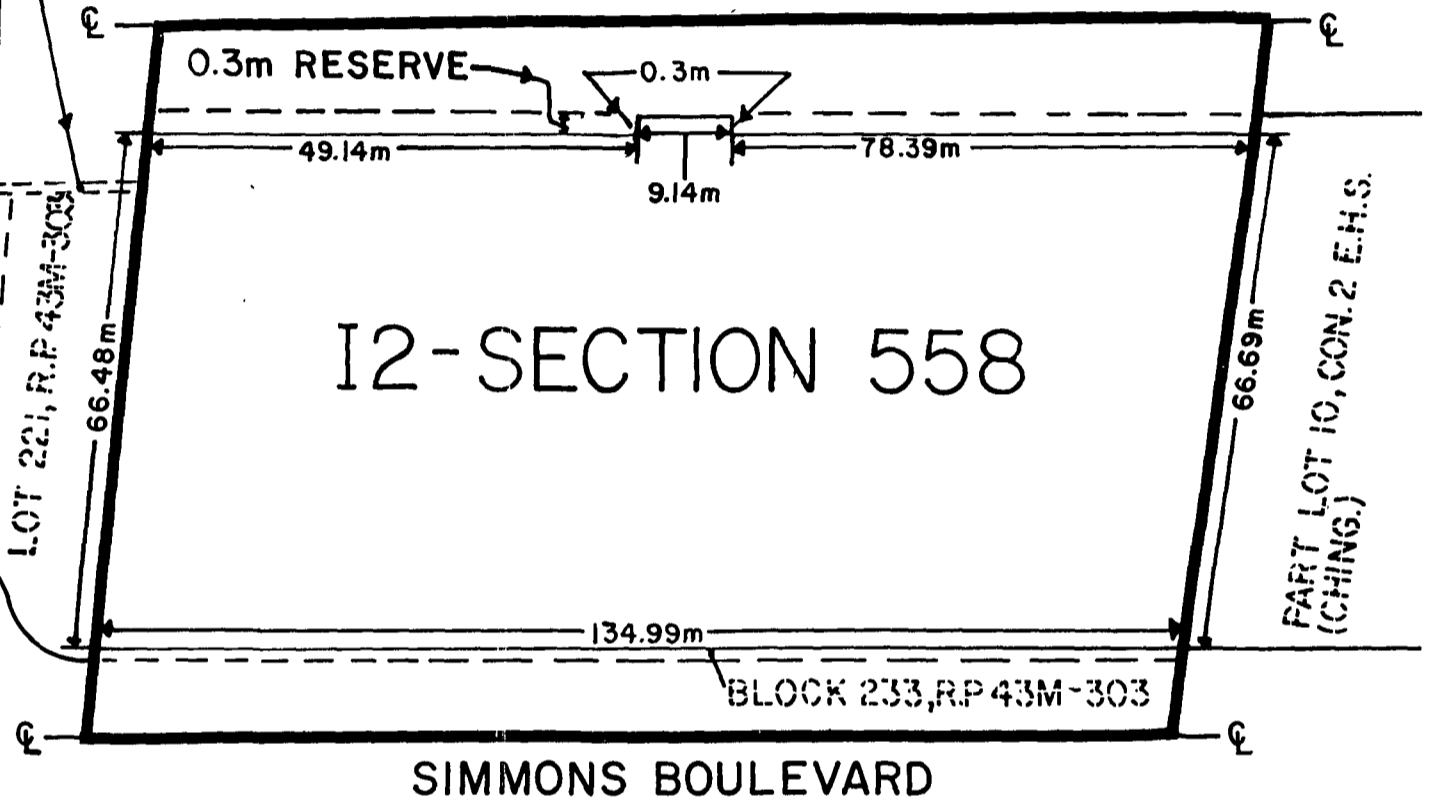
