BY-LAW NUMBER 135-74

A By-law to authorize a capital expenditure in the amount of \$265,000.00 for the construction of a 27.6 KV/15 KV Station and 27.6 KV C.N.R. Feeder by the Brampton Hydro Electric Commission.

WHEREAS the Brampton Hydro Electric Commission desires to undertake the construction of a 27.6 KV/15 KV Station and 27.6 KV C.N.R. Feeder;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. That the Brampton Hydro Electric Commission be authorized to undertake the construction of a 27.6 KV/15 KV Station and 27.6 KV C.N.R. Feeder as a capital expenditure at an estimated cost of \$265,000.00.
- 2. The Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$265,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ A FIRST, SECOND and THIRD TIME and PASSED in Open Council this 12th day of November, 1974.


