A By-law to amend By-law
Number 33-79 for the
regulation of Traffic

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to amend By-law Number 33-79, being a By-law for the regulation of traffic.

I. That Schedule VIII to By-law Number 33-79 be amended by the deletion therefrom of the following under the appropriate columns thereof.

THROUGH HIGHWAYS

<u>COLUMN 1</u> <u>Highway</u>	<u>COLUMN 2</u> <u>Between</u>
Bartley Bull Parkway	The west limit of Golfview Drive (most westerly intersection) and the south limit of Rambler Drive.
McMurchy Avenue	The south limit of Harold Street and the south limit of Steeles Avenue.

2. That Schedule VIII to By-law Number 33-79 be amended by the addition thereto of the following under the appropriate columns thereof.

<u>COLUMN 1</u> <u>Highway</u>	<u>THROUGH HIGHWAYS</u>	<u>COLUMN 2</u> <u>Between</u>
Bartley Bull Parkway		The west limit of Golfview Drive (westerly intersection) and the east limit of Golfview Drive (easterly intersection).
Bartley Bull Parkway		The east limit of Caldwell Crescent (westerly intersection) and the east limit of Caldwell Crescent (easterly intersection).
Bartley Bull Parkway		The east limit of Caldwell Crescent (easterly intersection) and the south limit of Rambler Drive.
McMurchy Avenue		The south limit of Harold Street and the south limit of Parkend Avenue
McMurchy Avenue		The north limit of Edwin Drive and the north limit of Steeles Avenue.

3. That Schedule IX to By-law Number 33-79 be amended by the addition thereto of the following under the appropriate columns thereof.
