



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 138-90

To amend By-law 151-88, (part of
Lot 6, Concession 5, W.H.S.,
geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:
 - (1) by changing, on Sheet 38B of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to AGRICULTURAL - SECTION 483 (A-SECTION 483), such lands being part of Lot 6, Concession 5, West of Hurontario Street in the geographic Township of Chinguacousy, now in the City of Brampton.
2. by adding thereto the following section:

"483 The lands designated A-SECTION 483 on Sheet 38B of Schedule A to this by-law:

483.1 shall only be used for:

 - (1) the purposes permitted in a A zone
 - (2) one mobile home as a temporary use

483.2 shall be subject to the following restrictions and requirements:

 - (1) the mobile home shall be erected a minimum distance of 150 metres from any property boundary
 - (2) the mobile home shall not exceed a gross floor area of 140 square metres

- (3) the mobile home shall only be occupied by a person employed on the land in connection with the permitted agricultural purpose
- (4) the mobile home shall not be permitted after September 1, 1993.

483.3 shall be subject to the requirements and restrictions relating to the A zone and all the general provisions of this by-law which are not in conflict with the ones set out in section 483.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 16th day of July 19 90.

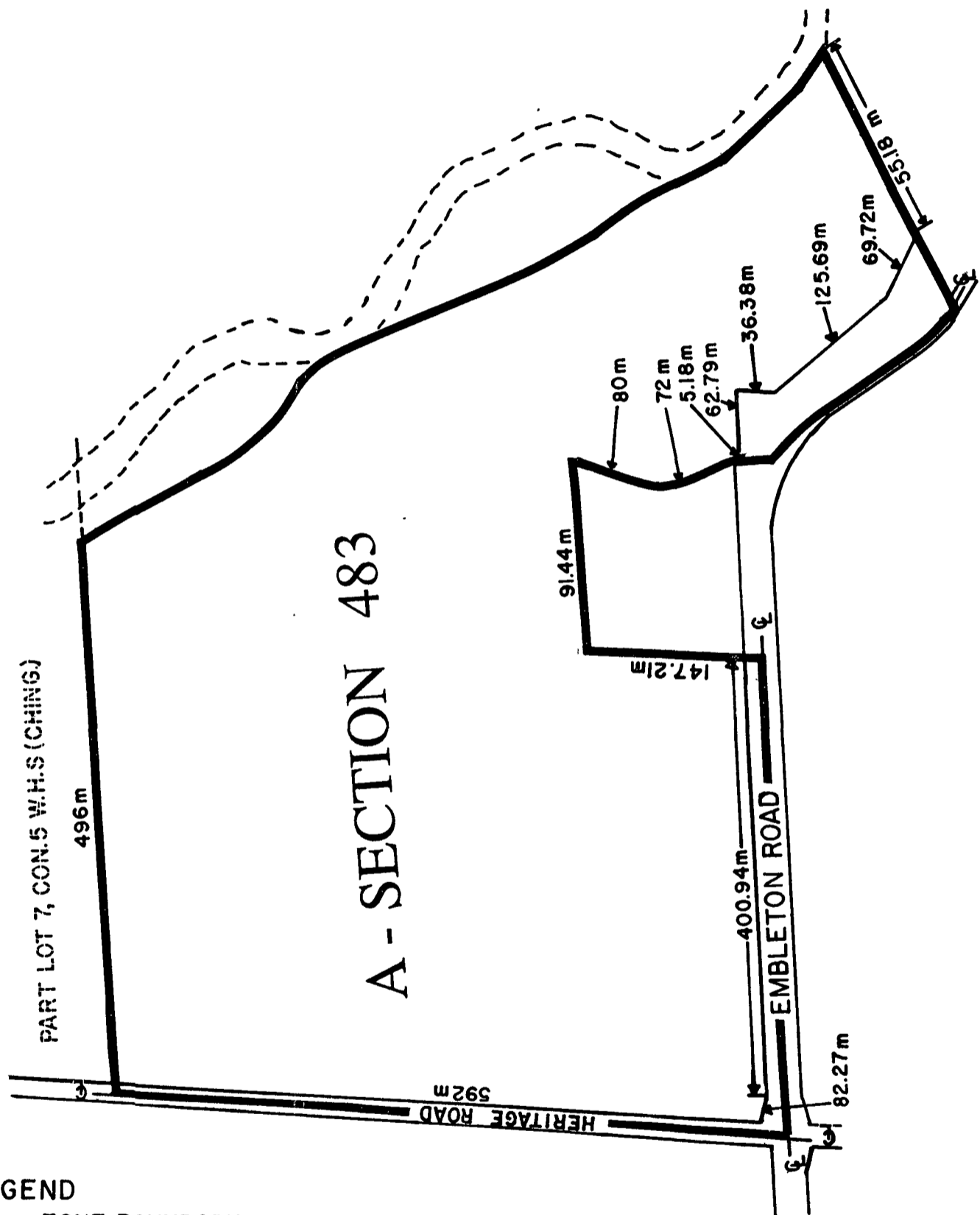
