BY-LAW

Number 139-2005

To amend By-law 93-93,

THROUGH HIGHWAYS, STOP SIGNS, RATE OF SPEED, HEAVY TRUCKS

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
