To repeal certain parts of the Consolidated Official Plan for the City of Brampton Planning Area and to adopt the Official Plan for the City of Brampton Planning Area.

The Council of The Corporation of the City of Brampton, in accordance with the provisions of the Planning Act, and the Regional Municipality of Peel Act, hereby enacts as follows:

1. By-law 106-76, which adopted the text and maps attached thereto as the Consolidated Official Plan of the City of Brampton (approved by the Minister of Housing on July 28, 1976 and subsequently amended) is hereby repealed, save and except for those parts of the Consolidated Official Plan of the City of Brampton Planning Area and amendments thereto which are herein set out:

2. By-law 209-80 is hereby repealed.
3. The text and maps attached hereto are hereby adopted as the Official Plan of the City of Brampton Planning Area.
4. The Clerk is hereby authorized and directed to make application to the Minister of Municipal Affairs and Housing for approval of the Official Plan of the City of Brampton Planning Area.
