# BY-LAW

*Number* 140-94

To amend By-law 93-93 to regulate use of highways and parking in the City of Brampton

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from the specified columns of Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Cornwall Road	The south limit of Clarence Street and the west limit of Lawrence Crescent (westerly intersection)
Sunforest Drive	The south limit of Sandalwood Parkway East and the north limit of Wexford Road

(2) by adding to the specified columns of Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Cornwall Road	The south limit of Clarence Street and the north limit of Eldomar Avenue
Cornwall Road	The south limit of Eldomar Avenue and the east limit of Harper Road
Cornwall Road	The west limit of Harper Road and the west limit of Lawrence Crescent (westerly intersection)
Sunforest Drive	The south limit of Sandalwood Parkway East and the north limit of Tremblay Street
Sunforest Drive	The south limit of Tremblay Street and the north limit of Wexford Road

(3) by adding to the specified columns of Schedule IV thereto the following items:

(4) by adding to the specified columns of Schedule X thereto the following items:

Cornwall Heights	40	Cornwall Road and Nanwood Drive
Cornwall Road	40	Cornwall Heights and Clarence Street

(5) by adding to the specified columns of Schedule XIV thereto the following item:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Tolton Drive	North	Newton Road and Centre Street North	Anytime

2. Subsections 1 (1), (2), (3), and (4) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel.
