
To amend By-law 56-83, as amended.

1. By-law 56-83, as amended, is hereby further amended:
  - (1) by changing, on Sheet 7 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL SECTION 520 (A- SECTION 520 ) to RESIDENTIAL SINGLE FAMILY B- SECTION 1784 (R1A-SECTION 1784) and OPEN SPACE (OS).

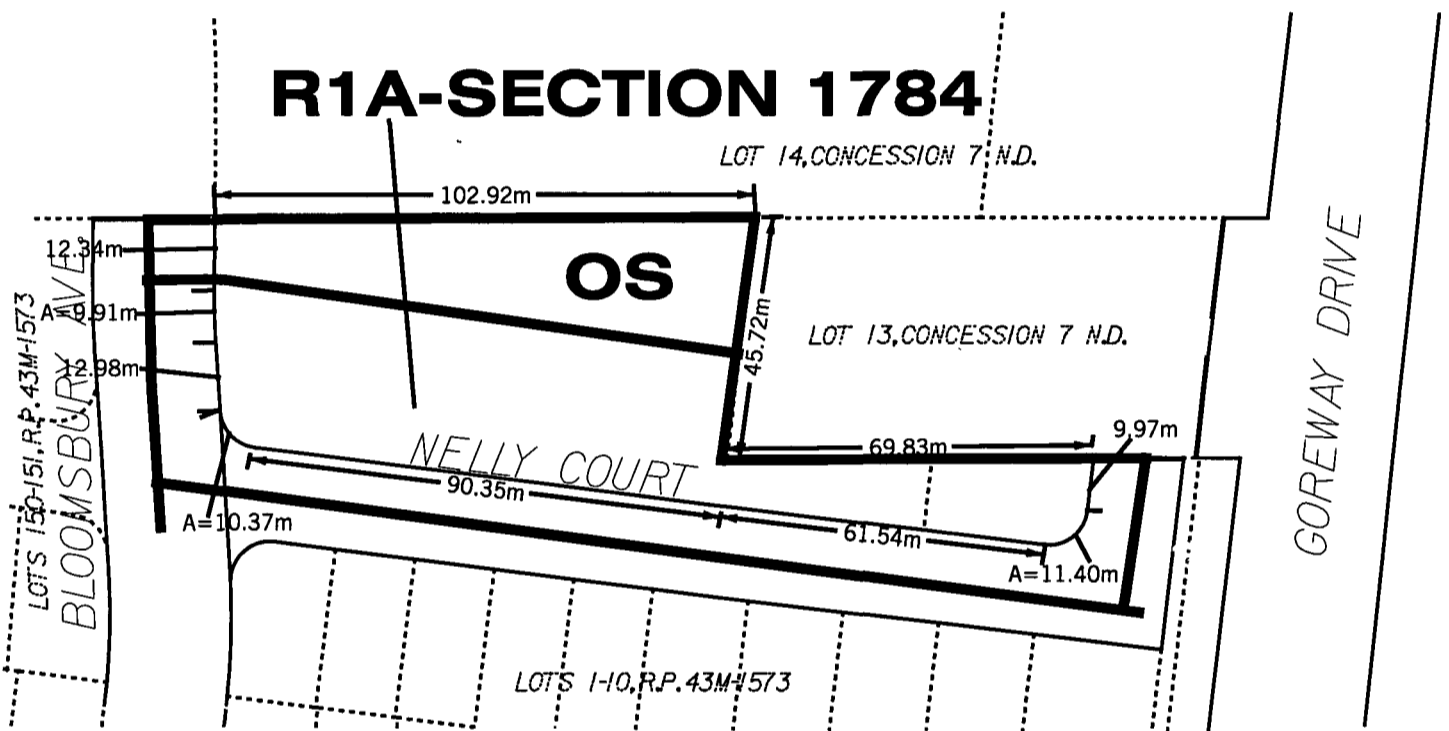

- m METRES



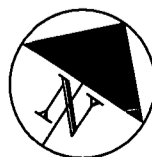
