
A By-law to amend Restricted Area By-law Number 861 as amended by By-law Number 877 as amended of the former Corporation of the Township of Chinguacousy as amended by By-law 354-73

The Council of the Corporation of the City of Brampton enacts as follows:

- By-law Number 861 as amended by By-law Number 877 as amended, be further amended by adding to Section 3, Subsections 2 and 3, zone classification known as Greenbelt Hazard GH.
- 2. Schedule "A" the zoning map forming part of By-law 861 as amended by By-law 877 as amended and as further amended by By-law 354-73 is hereby amended by deleting Schedules "A" and "B" to said By-law 354-73 and substituting therefore Schedule "A" which forms part of this By-law.
- 3. Parts 1 and 4 as shown on Schedule "A" hereto are hereby designated as a Greenbelt Hazard Zone. No buildings or structures of any kind other than those necessary for erosion control shall be constructed within the area designated Greenbelt Hazard on said Schedule "A" to this By-law.READ A FIRST, SECOND and THIRD TIME and PASSED in Open Council this 25th day of November, 1974.
