 The lands owned by The Corporation of the City of Brampton and described in Schedule A hereto attached, are hereby established as part of the public highway system of the City of Brampton.

The land situated in the City of Brampton, in the Regional Municipality of Peel, (formerly in the Township of Chinguacousy, in the County of Peel), containing by admeasurement an area of 0.039 acres, being composed of the part of Lot 9, Concession 5, East of Hurontario Street, more particularly described as follows:

PREMISING that the Southwest limit of Lot 9, Concession 5, East of Hurontario Street, has an assumed bearing of North 44 degrees, 17 minutes, 30 seconds West, in accordance with a plan of survey by J.D. Barnes, Ontario Land Surveyor, dated February 28, 1966 and relating all bearings herein thereto;

COMMENCING at a point in the said southwesterly limit of Lot 9, distant 290.78 feet, measured on a bearing of South 44 degrees, 17 minutes, 30 seconds East, along the southwesterly limit of Lot 9, from the most westerly angle thereof;

THENCE South 44 degrees, 17 minutes, 30 seconds East, continuing along the said southwesterly limit of Lot 9 a distance of 100.00 feet;

THENCE North 66 degrees, 01 minutes, 00 seconds East, 18.12 feet, to a survey monument;

THENCE North 44 degrees, 17 minutes, 30 seconds West, along a line drawn parallel to the said southwesterly limit of Lot 9, and distant 17.00 feet measured northeasterly therefrom and at right angles thereto, 100.00 feet to a survey monument;

THENCE South 66 degrees, 01 minutes, 00 seconds West, 18.12 feet, to the point of commencement.

The herein described parcel of land is further shown outlined on a plan of survey prepared by R.R. Scott, Ontario Land Surveyor, dated July 2, 1969 and hereto attached.

The land situated in the City of Brampton, in the Regional Municipality of Peel, (formerly in the Township of Chinguacousy, in the County of Peel), being the part of Lot 9, Concession 5, East of Hurontario Street, containing by admeasurement 0.115 acres, more particularly described as follows: PREMISING that the bearings berein are referred to the northwesterly limit of the road allowance between Lots 5 and 6, Concession 5, East of Hurontario Street (the King's Highway Number 7) assumed to be North 39 degrees, 30 minutes, 30 seconds East in accordance with Department of Highways Plan P-1899-15;

COMMENCING at the most westerly angle of the said Lot 9;

THENCE South 44 degrees, 17 minutes, 30 seconds East, along the southwesterly limit of the said Lot 9, a distance of 290.78 feet, to a point;

THENCE North 66 degrees, 01 minutes, 00 seconds East, 18.12 feet, to a survey monument;

THENCE North 44 degrees, 17 minutes, 30 seconds West, along a line drawn parallel to the southwesterly limit of the said Lot 9 and distant 17.00 feet measured perpendicularly therefrom and at right angles thereto distant 289.76 feet to a survey monument;

THENCE North 44 degrees, 32 minutes, 30 seconds West, 9.04 feet, to a point in the northwesterly limit of the said Lot 9;

THENCE South 40 degrees, 56 minutes, 00 seconds West, along the last mentioned northwesterly limit 17.08 feet to a point being the point of commencement.


