

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 143-2004

To approve the expropriation of Part of Lots 12 and 13, Concession 3 WHS, designated as Part 1 on Plan 43R-24878 And Part 3 on Plan 43R-28413 (Chinguacousy Road widening)

WHEREAS the Council of The Corporation of the City of Brampton as expropriating authority, on the 24th day of November, 2003, passed By-law 368-2003, authorizing the expropriation of the lands described in Schedule A to this by-law, and further, authorizing the Clerk to sign notice and advertisements on behalf of The Corporation of the City of Brampton as required by the Expropriations Act, (R.S.O. 1990, c.E.26, as amended);

AND WHEREAS The Corporation of the City of Brampton has complied with the requirements of the <u>Expropriations Act</u> regarding service of notice of the application for approval to expropriate and the advertisement of said notice;

AND WHEREAS no person requested a hearing of necessity as to whether the proposed expropriation was fair, sound and reasonably necessary in the achievement of the objectives of expropriating authority within the 30 day time period following the first publication of the notice;

AND WHEREAS The Corporation of the City of Brampton, in its capacity as the expropriating authority, has applied to the council of the Corporation of the City of Brampton in its capacity as the approving authority to obtain the approval to expropriate the lands described in Schedule A attached hereto;

AND WHEREAS the Council of The Corporation of the City of Brampton, it its capacity as the approving authority, has considered the application of The Corporation of the City of Brampton to expropriate the lands described in Schedule A to this by-law;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. The expropriation of the lands described in Schedule A to this by-law is hereby approved by the Council of The Corporation of the City of Brampton;
- 2. The lands described in Schedule A to this by-law are hereby expropriated for the purpose of the widening of Chinguacousy Road; and

3. The Mayor and Clerk are hereby authorized to execute on behalf of The Corporation of the City of Brampton all documents necessary to carry out this expropriation.
