PASSING OVER A BRIDGE

WHEREAS subsection 2 of section 104 (b) of The Highway Traffic Act (R.S.O. 1980 Chapter 198 as amended) provides that:-

The municipal corporation or other authority having jurisdiction over a bridge may by by-law approved by the Ministry limit the gross vehicle weight of any vehicle or any class thereof passing over such bridge, and the requirements of subsection (1) with respect to the posting up of notice apply thereto.

AND WHEREAS it is deemed expedient to limit the weight of vehicles passing over bridges in the Corporation of the City of Brampton NOW THEREFORE the Council of the Corporation of the City of Brampton enacts as follows:-

 The gross vehicle weight of any vehicle or combination of vehicles passing over the bridges listed in Column 1 of Schedule A to this by-law shall be limited to the weights set out in the corresponding line of Column 2 of Schedule A to this by-law.




