WHEREAS By-law 23-80 was passed on the 28th day of January, 1980, to designate the City of Brampton Library and Art Gallery as a place to keep the originals of all by-laws and minutes of the proceedings of the Council for the former Corporation of the Township of Chinguacousy for the years from incorporation up to and including 1973;

AND WHEREAS, at the request of the Brampton Public Library and Art Gallery, those records are now to be transferred to the Region of Peel Archives;

AND WHEREAS Section 75 of the Municipal Act R.S.O. 1990, c..M.45, provides that City Council may agree to the transfer of those documents;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. That By-law 23-80 is hereby repealed.
- That the Region of Peel Archives is hereby appointed as a place to keep the originals of 2. those records of the former Corporation of the Township of Chinguacousy. as set out in Schedule A to this by-law.
