MEMORANDUM OF AGREEMENT made in duplicate this Blay of five

BETWEEN:

EILEEN THERESA MULLIN, of the City of Mississauga, in the Regional Municipality of Peel

herein called the Party

OF THE FIRST PART

- and -

THE CORPORATION OF THE CITY OF BRAMPTON in the Regional Municipality of Peel

herein called the Party

OF THE SECOND PART

WHEREAS Bramtel Limited has recently applied to the Land
Severance Committee of the Regional Municipality of Peel for
consent to sever and convey the lands and premises more particularly
described in Schedule "A" annexed.

AND WHEREAS it was a condition of such severance being approved that the Party of the First Part do enter into this agreement and cause it to be registered in the appropriate Registry Office therefor.

NOW THIS INDENTURE WITNESSETH that in consideration of the sum of ONE (\$1.00) DOLLAR of lawful money of Canada to each of the parties paid, receipt whereof is by each of the parties acknowledged, the parties agree as follows:

1. The Party of the First Part does hereby consent and agree that upon registration of a deed to her of the lands described in Schedule "A" annexed that the same shall thereupon be merged with the further lands of hers more particularly described in Schedule "B" annexed to the intent that the two parcels (lands in Schedule "A" and lands in Schedule "B") shall form one parcel and will be owned and used as such; and further that no conveyance of any part of the combined two parcels will be made unless and until an application to the Land Severance Committee therefor has been approved.

2. The aforesaid consent and agreement shall be for the benefit of and binding upon the heirs, administrators, successors and assigns of the parties hereto.

ALL AND SINGULAR that certain parcel or tract of land and premises situate lying and being in the City of Brampton, in the Regional Municipality of Peel, (formerly in the Town of Brampton, in the County of Peel) and being composed of part of Lot 4, as shown on a plan registered in the Registry Office for the Registry Division of Peel (No. 43) as Plan 644, and being further shown as Part 1 on a Plan filed for reference as No. 43R-4963.

SCHEDULE "B"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Brampton, in the Regional Municipality of Peel (formerly Town of Brampton, County of Peel) and Province of Ontario, and being composed of part of Lot Five as shown on Plan 644 (Brampton) registered in the Registry Office for the Registry Division of Peel (No. 43) the boundaries of which said parcel may more particularly be described as follows and

PREMISING that the south westerly limit of the said lot five has a governing bearing of north 44 degrees 21 minutes 00 seconds west and relating all bearings quoted herein, thereto; COMMENCING at an iron bar found planted and marking the most westerly angle of the said Lot five;

THENCE south 44 degrees 21 minutes 00 seconds east along the said southwesterly limit of the said Lot five, 50.07 feet to an iron bar planted;

THENCE north 45 degrees 38 minutes 00 seconds east, 300.00 feet more or less, to an iron bar planted in the northeasterly limit of the said Lot Five;

THENCE north 44 degrees 21 minutes 00 seconds west, along the last said limit, 68.84 feet, more or less, to an iron bar found planted marking the most northerly angle of the said Lot five; THENCE south 42 degrees 03 minutes 00 seconds west along the north westerly limit of the said lot five, 300.51 feet, more or less to the point of commencement.

TOGETHER WITH AND SUBJECT TO reciprocal rights-of-way, being strips of land 15.00 feet in perpendicular width lying on either side and adjacent to the southeasterly limit of the hereinbefore described parcel.
