# BY-LAW

Number 152-89

To amend By-law 56-83  
(part of Lot 4, Concession  
7, N.D.)

The Council of the Corporation of the City of Brampton  
ENACTS as follows:

1. By-law 56-83, as amended, and as further amended by By-law 87-85, is hereby further amended:

(1) by changing, on Sheet 18 of Schedule A, thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to INDUSTRIAL M3 - SECTION 529 (M3-SECTION 529) and INDUSTRIAL M4 -SECTION 528 (M4-SECTION 528), such lands being part of Lot 4, Concession 7, N.D., in the geographic Township of Toronto Gore.

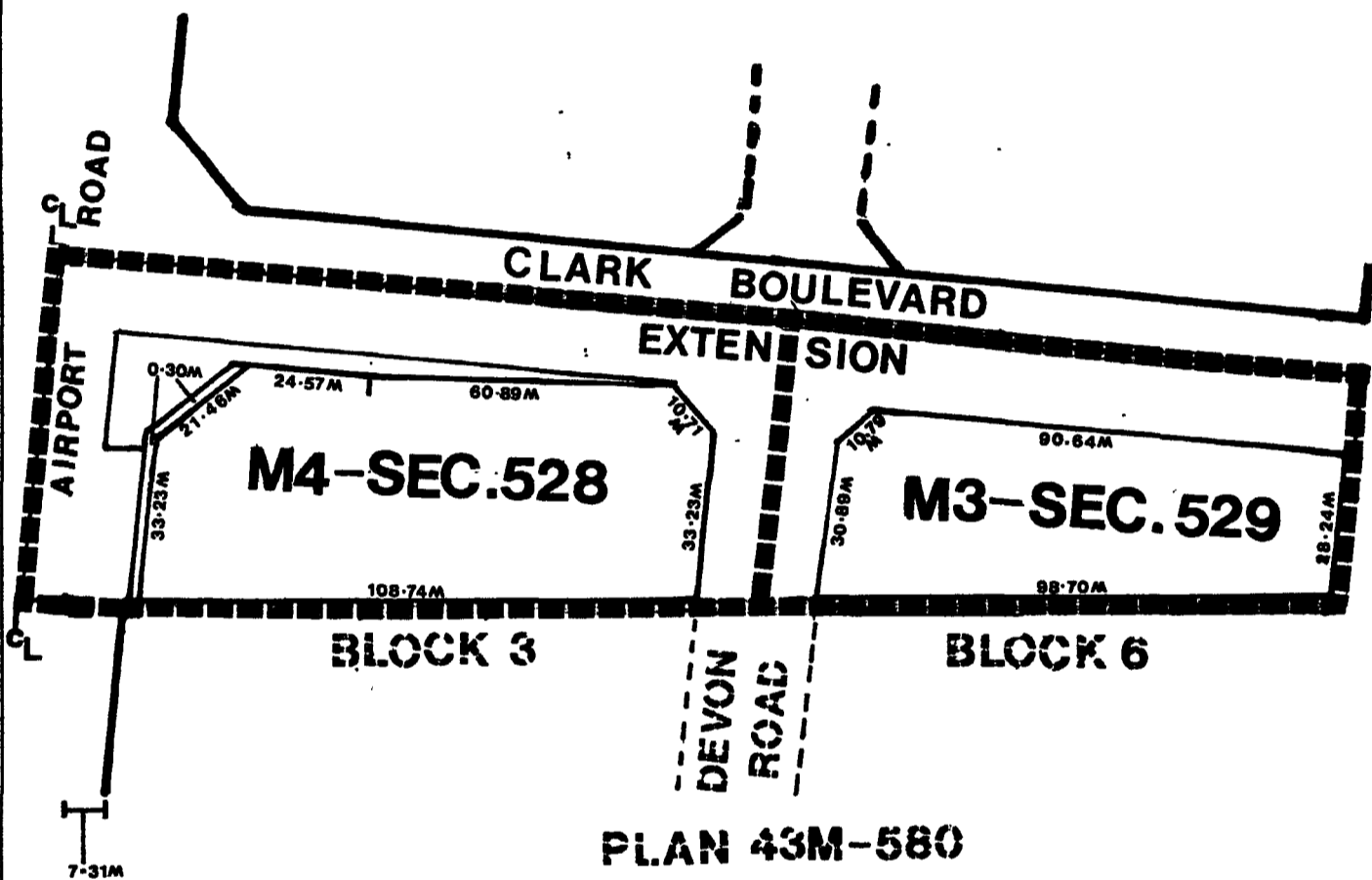
