BY-LAW

Number 152-2011

To amend Traffic By-law 93-93 by amending the Schedules relating to HEAVY TRUCKS (Schedule XI), STOP SIGNS (Schedule IV) and THROUGH HIGHWAYS (Schedule III)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended as follows:

(1) by adding to Schedule XI thereto the following items:

HEAVY TRUCKS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 TIMES OR DAYS
Financial Drive	Steeles Avenue West and the south limit of the City of Brampton	11:00 p.m. – 6:30 a.m.

(2) by removing from Schedule IV thereto the following items:

STOP SIGNS

Harbourtown Crescent/Stoneylake Avenue @ Southlake Boulevard	Eastbound on Stoneylake Avenue
Harbourtown Crescent/Stoneylake Avenue @ Southlake Boulevard	Southbound on Southlake Boulevard
Harbourtown Crescent/Stoneylake Avenue @ Southlake Boulevard	Northbound on Southlake Boulevard
Harbourtown Crescent/Stoneylake Avenue @ Southlake Boulevard	Westbound on Harbourtown Crescent
Dwellers Road and Vintage Gate (east intersection)	Eastbound on Dwellers Road
Dwellers Road and Vintage Gate (east intersection)	Southbound on Vintage Gate
Dwellers Road and Vintage Gate (east intersection)	Northbound on Vintage Gate

(3) by adding to Schedule IV thereto the following items:

Harbourtown Crescent/Stoneylake Avenue and Southlake Boulevard	Eastbound on Stoneylake Avenue

Harbourtown Crescent/Stoneylake Avenue and Southlake Boulevard	Northbound on Southlake Boulevard
Harbourtown Crescent/Stoneylake Avenue and Southlake Boulevard	Westbound on Harbourtown Crescent
Dwellers Road and Vintage Gate (easterly intersection)	Eastbound on Dwellers Road
Dwellers Road and Vintage Gate (easterly intersection)	Southbound on Vintage Gate
Dwellers Road and Vintage Gate (easterly intersection)	Northbound on Vintage Gate

(4) by removing from Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Vintage Gate	The south limit of Dwellers Road (west intersection) and the south limit of Dwellers Road (east intersection)
Vintage Gate	The east limit of Fletchers Creek Boulevard and the north limit of Dwellers Road (east intersection)


(5) by adding to Schedule III thereto the following items:


THROUGH HIGHWAYS


COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Vintage Gate	The south limit of Dwellers Road (westerly intersection) and the south limit of Dwellers Road (easterly intersection)
Vintage Gate	The east limit of Fletchers Creek Boulevard and the north limit of Dwellers Road (easterly intersection)


