# BY-LAW

Number 155-92

To amend By-law 151-88, as amended,  
(Part of Lot 11, Concession 6, E.H.S.,  
in the geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS  
as follows:

1. By-law 151-88, as amended, is hereby further amended:

- (1) by changing, on Sheet 30 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY C - SECTION 542 (R1C - SECTION 542), RESIDENTIAL SINGLE FAMILY B - SECTION 541 (R1B-SECTION 541), INSTITUTIONAL ONE-SECTION 550 (I1 - SECTION 550) and OPEN SPACE (OS), such lands being part of Lot 11, Concession 6, East of Hurontario Street, in the geographic Township of Chinguacousy. (**Note:** Sections 542, 541 and 550 were added to By-law 151-88 by By-law 300-92).

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN  
COUNCIL, this 13th day of July, 1992.


