To amend By-law 193-83 being a by-law for the regulation of traffic.

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to amend By-law 193-83 being a by-law for the regulation of traffic:

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

 By-law 193-83, as amended, is hereby further amended by deleting from Schedule VIII thereof the following items under the appropriate columns thereof:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY

COLUMN 2 BETWEEN

Isabella Street

The south limit of English Street and the north limit of Rosedale Avenue.

North Hampton Street

The east limit of North Park Drive and the west limit of Dixie Road.

2. By-law 193-83, as amended, is hereby further amended by adding to Schedule VIII thereof the following items under the appropriate columns thereof:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY COLUMN 2 BETWEEN

Isabella Street

The south limit of English Street and the north limit of Vodden Street.

Isabella Street

The south limit of Vodden Street and the north limit of Rosedale Avenue.

Northampton Street

The east limit of Newbridge Crescent and the west limit of Newcastle Crescent (easterly intersection).

Northampton Street

The east limit of Newcastle Crescent (easterly intersection) and the west limit of Dixie Road.

Vodden Street

The west limit of Main Street and the East limit of English Street/Pleasantview Avenue.

Vodden Street

The west limit of English Street/Pleasantview Avenue and the south limit of Williams Parkway.

3. By-law 193-83, as amended, is hereby further amended by adding to Schedule IX thereof the following items under the appropriate columns thereof:

STOP SIGNS

COLUMN 1 INTERSECTION

COLUMN 2 FACING TRAFFIC

Northampton Street and Newbridge Crescent

Westbound on Northampton Street

Northampton Street and Newbridge Crescent

Eastbound on Northampton Street.

Northampton Street and Newbridge Crescent

Northbound on Newbridge Crescent.

Northampton Street and Newcastle Crescent (easterly intersection).

Westbound on Northampton Street.

Northampton Street and Newcastle Crescent (easterly intersection)

Eastbound on Northampton Street.

Northampton Street and Newcastle Crescent (easterly intersection)

Northbound on Newcastle Crescent.

4. This By-law shall not come into force until approved by the Council of The Regional Municipality of Peel.
