The Council of The Corporation of the City of Brampton ENACTS as follows:


- 1. By-law 200-82, as amended, is hereby further amended:
 - (1) by changing on Sheet 39 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this bylaw from RESIDENTIAL TWO FAMILY C (HOLDING) SECTION 367 (R2C(H) SECTION 367) and RESIDENTIAL TWO FAMILY C (HOLDING) SECTION 368 (R2C(H) SECTION 368) to RESIDENTIAL TWO FAMILY C SECTION 367 (R2C SECTION 367) and RESIDENTIAL TWO FAMILY C (R2C).
 - (2) by deleting therefrom, section 367. and substituting therefor the following:
 - "367. The lands designated R2C SECTION 367 on Sheet 39 of Schedule A to this by-law:"
 - (3) by deleting therefrom section 367.2(4).
 - (4) by deleting therefrom, section 368.


