The Council of The Corporation of the City of Brampton ENACTS as follows:


1. By-law 151-88, as amended, is hereby further amended:
  - (1) by changing on Sheet 22 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY D - SECTION 1133 (R1D - SECTION 1133) and RESIDENTIAL TWO FAMILY A - SECTION 1134 (R2A - SECTION 1134) to RESIDENTIAL SINGLE FAMILY D - SECTION 1133 (R1D - SECTION 1133) and RESIDENTIAL TWO FAMILY A - SECTION 1134 (R2A - SECTION 1134).

LOT 15, CONCESSION 3 W.H.S.

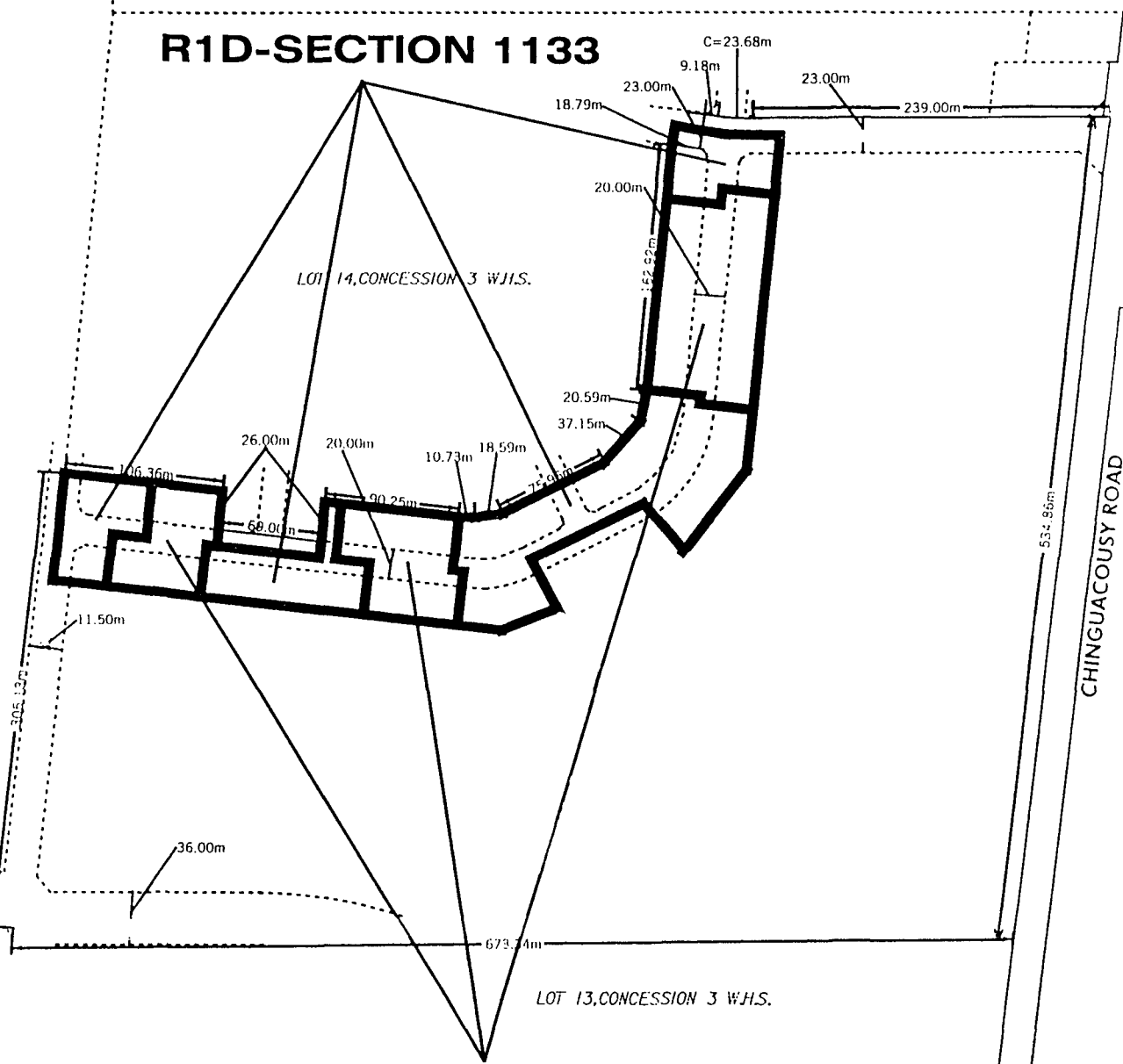

**R2A-SECTION 1134**

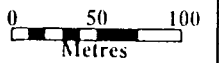
CHINGUACOUSY ROAD

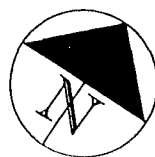
**PART LOT 14, CONCESSION 3 W.H.S.**


