## **BY-LAW**

Number <u>160-84</u>

To provide for a drainage works in Lots 11, 12 and 13, Concession 4, W.H.S., geographic Township of Chinguacousy (Rowntree Drain)

WHEREAS the requisite number of owners have petitioned the council of the City of Brampton in the Regional Municipality of Peel, in accordance with the provisions of the <u>Drainage Act</u>, requesting that the following lands be drained by a drainage works:

Lots 12 and 13, Concession 3, in the geographic Township of Chinguacousy

AND WHEREAS the council of the City of Brampton in the Regional Municipality of Peel has obtained a report, prepared by Jack K. Young and dated 12 April 1984, on the proposed drainage works;

AND WHEREAS the estimated total cost of constructing the drainage works is \$56,100.00;

AND WHEREAS \$250.00 is the amount to be contributed by the City of Brampton for construction of the drainage works; AND WHEREAS \$400.00 is being assessed in the Town of Caledon in the Regional Municipality of Peel;

AND WHEREAS the council is of the opinion that the drainage of the area is desirable;

NOW THEREFORE the council of the City of Brampton, pursuant to the <u>Drainage Act</u>, ENACTS AS FOLLOWS:

- The report prepared by Jack K. Young and dated 12 April 1984 is hereby adopted, and the drainage works as therein indicated and set forth is hereby authorized, and shall be completed in accordance therewith.
- 2. To pay for the cost of constructing the drainage works, a special rate shall be levied upon lands and roads, as set forth in Schedule A to this by-law, to be collected in the same manner and at the same time as other taxes are collected.
- All assessments are payable in the first year in which the assessment is imposed.


