A By-law to amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), FIRE ROUTES (Schedule XXII), DESIGNATED BICYCLE LANES (Schedule XXX) and HEAVY TRUCKS (Schedule XI)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:
