To amend By-law 200-82 as amended, By-law 56-83 as amended,
By-law 139-84 as amended, and By-law 151-88 as amended

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82 as amended, By-law 56-83 as amended, By-law 139-84 as amended, and By-law 151-88 as amended are hereby further amended
 - (1) by changing the reference of the second subsections (d) and (e) of **Section 10.14 Provisions for Group Homes and Supportive Lodging Houses** in SECTION 10.0 GENERAL PROVISIONS FOR RESIDENTIAL ZONES from ALL these By-laws to (f) and (g) and re-lettering the subsequent subsections from (f), (g), and (h) to (h), (i), and (j).
2. By-law 200-82, as amended, is hereby further amended:
 - (1) by replacing the words "R4A-Section 52" on Schedule A with "R3-Section 52".
 - (2) by deleting Sections 235.1(4) and 235.2(2) in Section 235.
 - (3) by replacing the words "SCHEDULE C-SECTION 185" in Section 285 with "SCHEDULE C-SECTION 285".
3. By-law 139-84, as amended, is hereby further amended:
 - (1) by replacing the words "standard restaurant" in Sections 749 and 757 with "convenience restaurant".
4. By-law 151-88, as amended, is hereby further amended:
 - (1) by deleting the words "subject to the requirements and restrictions set out in section 10.16" from Section 174.
 - (2) by changing, in Section 747, the second "747.3" to "747.5".




DECLARATION
