By-law 200-82, as amended, is hereby further amended: 2. by replacing the words "R4A-Section 52" on Schedule A with "R3-(1)Section 52". by deleting Sections 235.1(4) and 235.2(2) in Section 235. (2) by replacing the words "SCHEDULE C-SECTION 185" in Section 285 (3) with "SCHEDULE C-SECTION 285". By-law 139-84, as amended, is hereby further amended: 3. by replacing the words "standard restaurant" in Sections 749 and 757 with (1)"convenience restaurant". By-law 151-88, as amended, is hereby further amended: 4. by deleting the words "subject to the requirements and restrictions set out (1)in section 10.16" from Section 174. by changing, in Section 747, the second "747.3" to "747.5".
