A By-law to Amend Development Charges By-law 227-2009 as amended by By-law 230-2010, pertaining to Roads (Industrial and Office Discount Rates)

WHEREAS By-law 227-2009 was passed pursuant to the Development Charges Act, 1997, s. 2 (1); and

WHEREAS By-law 230-2010 was passed pursuant to the Development Charges Act, 1997, s. 2 (1) to amend By-law 227-2009; and

WHEREAS pursuant to Council Resolution <u>**CI33-2011**</u> approved on June 22, 2011, and the Development Charges Act, 1997, s. 2 (1), it is deemed appropriate to amend By-law 227-2009 as amended by By-law 230-2010;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. That By-law 227-2009 as amended by By-law 230-2010 is hereby amended by deleting Schedules A, B, C & D and substituting therefor the Schedules set out in Appendix 1 to this By-law.
- That By-law 227-2009 as amended by By-law 230-2010 is hereby amended by deleting from subsection 14 (4) "the period commencing on August 5th, 2010 and ending on August 5th, 2011", and substituting therefor "the period commencing on August 5th, 2011 and ending on August 5th, 2012".
- 3. This by-law shall come into force and effect as of August 5, 2011.
