



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 168-94

To amend By-law 151-88

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:
 - (1) by deleting from section 5.0 (DEFINITIONS) the definition for ANIMAL HOSPITAL and substituting therefor, the following:

"ANIMAL HOSPITAL shall mean the premises where animals which are household pets and not agricultural livestock, are kept for the purposes of veterinary treatment within a building or structure, and shall include the offices of a veterinary surgeon, but shall not include the overnight boarding of animals not receiving veterinary treatment or outside runs."
 - (2) by adding to section 6.0 (GENERAL PROVISIONS FOR ALL ZONES) thereto, the following:

"6.29 Animal Hospitals

The provisions of this by-law shall not apply to prevent lands which are zoned C1, C2, C3, SC, HC1, HC2, RC, CA, M1, M1A, M2, M2A, M3, M3A, M4 and M4A, including any lands so zoned but subject to a site specific section in Part III of this by-law, being used for the purposes of an animal hospital subject to the following requirements and restrictions:

- a) there shall be no overnight boarding of animals not receiving veterinary treatment;
 - b) there shall be no outside runs; and
 - c) shall be for the treatment of only animals which are household pets and not agricultural livestock."
- (3) by adding to section 31.1 (COMMERCIAL ONE ZONE - C1) thereto, the following:
- "31.1.1(a)(11) an animal hospital."
- (4) by adding to section 31.2 (COMMERCIAL TWO ZONE - C2) thereto, the following:
- "31.2.1(a)(24) an animal hospital."
- (5) by adding to section 31.3 (COMMERCIAL THREE ZONE - C3) thereto, the following:
- "31.3.1(a)(27) an animal hospital."
- (6) by adding to section 33.1 (SERVICE COMMERCIAL ZONE - SC) thereto, the following:
- "33.1.1(a)(16) an animal hospital."
- (7) by adding to section 34.1 (HIGHWAY COMMERCIAL ONE ZONE - HC1) thereto, the following:
- "34.1.1(a)(14) an animal hospital."
- (8) by adding to section 33.2 (HIGHWAY COMMERCIAL TWO ZONE - HC2) thereto, the following:

"34.2.1(e) an animal hospital."

- (9) by adding to section 35.1 (RECREATION COMMERCIAL ZONE - RC) thereto, the following:

"35.1.1(l) an animal hospital."

- (10) by adding to section 36.1 (COMMERCIAL AGRICULTURAL ZONE - CA) thereto, the following:

"36.1.1(d) an animal hospital."

- (11) by adding to section 41.1 (INDUSTRIAL ONE ZONE - M1) thereto, the following:

"41.1.1(b)(5) an animal hospital."

- (12) by adding to section 41.2 (INDUSTRIAL ONE A ZONE - M1A) thereto, the following:

"41.2.1(b)(5) an animal hospital."

- (13) by adding to section 42.1 (INDUSTRIAL TWO ZONE - M2) thereto, the following:

"42.1.1(b)(5) an animal hospital."

- (14) by adding to section 42.2 (INDUSTRIAL TWO A ZONE - M2A) thereto, the following:

"42.2.1(b)(5) an animal hospital."

- (15) by adding to section 43.1 (INDUSTRIAL THREE ZONE - M3) thereto, the following:

"43.1.1(b)(4) an animal hospital."

- (16) by adding to section 43.2 (INDUSTRIAL THREE A ZONE - M3A) thereto, the following:

"43.2.1(b)(4) an animal hospital."


- (17) by adding to section 44.1 (INDUSTRIAL FOUR ZONE - M4) thereto, the following:

"44.1.1(b)(4) an animal hospital."


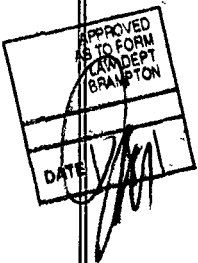
- (18) by adding to section 44.2 (INDUSTRIAL FOUR A ZONE - M4A) thereto, the following:

"44.2.1(b)(4) an animal hospital."
