AND WHEREAS the City of Brampton is prepared to release its interest in the said lands subject to retention of the aforesaid right-of-way;

NOW THEREFORE WITNESSETH that in consideration of other good and valuable consideration and the sum of TWO DOLLARS (\$2.00) of lawful money of Canada, the receipt whereof is hereby acknowledged, the Party of the First Part does hereby release unto the Party of the Second Part all of its interest under Instrument Number 75693 VS in the lands described in Schedule "A" hereto.

SAVE AND EXCEPT the rights of the Party of the First Part in the nature of a right-of-way over the said lands as contained in Instrument Number 29216 (Chinguacousy) registered in the Registry Office for the Registry Division of Peel (No. 43).
