BY-LAW

Number 171-93

To change the name of Woodsmere Road
on Registered Plan 43M-1026

WHEREAS the Council of the City of Brampton deems it expedient to change the name of Woodsmere Road;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The name of the street shown as "Woodsmere Road" on Registered Plan 43M-1026, which is described in Schedule A attached hereto, is changed to "Peter Robertson Boulevard";
2. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.

READ a FIRST, SECOND, and THIRD TIME, and PASSED in open Council this 13th day of September, 1993.




- (i) Thursday, August 19, 1993;

TAKE NOTICE that the Council of The Corporation of the City of Brampton proposes to enact a by-law under paragraph 111, section 210 of the Municipal Act to change the name of the public highway shown on Registered Plan 43M-1026 as "Woodsmere Road" to "Peter Robertson Boulevard"
